Amend Development and Transitway Agreement with the City of SeaTac for the South 200th Link Extension

PROPOSED ACTION

Authorizes the chief executive officer to execute an amendment to the Development and Transitway Agreement with the City of SeaTac for the South 200th Link Extension in the amount of \$2,989,700, for a new total authorized amount not to exceed \$6,432,000.

KEY FEATURES SUMMARY

The Development and Transit Way Agreement defines the specific development standards and permitting conditions for the South 200th Link Extension located within the City of SeaTac. The amendment addresses the following terms:

- Traffic Mitigation: Reduces the number of traffic impact mitigation measures that Sound Transit will be required to provide and transfers \$3.4 million in funding for the mitigation measures to the City of SeaTac to construct an alternative mitigation measure. Sound Transit will provide the funding to the City, provided the City meets certain deadlines relating to environmental review, securing additional funding and awarding the construction contract. This action will increase the amount contributed to the City of SeaTac, however the transfer will not increase the amount Sound Transit planned for traffic mitigation measures and is cost-neutral for the project. The amendment also identifies the federal provisions governing the City's procurement of the alternative mitigation measure.
- Non-Motorized Improvements: Sound Transit will provide all non-motorized transportation improvements required by the agreement, reducing mitigation payments to the City by \$410,300.
- Fire/Life-Safety: Under the original agreement, Sound Transit provided funding toward upgraded firefighting apparatus. The amendment identifies the federal procurement provisions governing the City's procurement in accordance with the most recent guidance from FTA regarding use of federal funds.

BACKGROUND

The South 200th Link Extension will extend light rail approximately 1.6 miles from SeaTac/Airport Station to the Angle Lake Station, spanning South 200th Street. The design features an elevated light rail guideway, an elevated station, and a detached park-and-ride facility with long-term minimum capacity of 700 stalls in a parking garage. Additional surface parking will be provided while Angle Lake Station serves as the temporary southern terminus of the light rail system. The

additional surface parking will increase the total to 1,100 stalls. Station amenities include on-street bus pullouts at the station, an off-street passenger drop-off area, secured bicycle parking, and improved pedestrian and bicycle connections in the station vicinity.

The Development and Transitway Agreement for the South 200th Link Extension was executed July 20, 2012. The Agreement identified traffic impact mitigation measures that would be provided by Sound Transit, and required Sound Transit to make payments to the City for mitigation measures that would be provided by the City. Several of the identified mitigation measures would have adversely affected businesses and property owners in the area of the South 200th Street/International Boulevard intersection. However, the Agreement allowed either party to propose alternative mitigation measures, so long as they performed at least as well as those identified in the Agreement. If the parties agreed to implement an alternative measure that eliminated the need for one or more identified measures, the Agreement allows the value of the eliminated measure or measures to be transferred to the construction of the alternative measures.

As documented in the term sheet executed October 30, 2012, the City-proposed alternative mitigation measure performs equally well or better than the mitigation measures enumerated in the Agreement and will eliminate the need for a number of the identified mitigation measures. The increased amount in this amendment is cost-neutral for the project because the additional funding available to be transferred to the City for construction of the alternative mitigation measure is identical to the estimated cost to Sound Transit to provide the mitigation measures that will be eliminated by the alternative mitigation measure.

The City's codes require high-capacity transit (HCT) projects to provide improvements to pedestrian and bicycle transportation networks in the HCT station area based on an assessment of access to the station. The Agreement defines the pedestrian improvements that the project will fund or provide directly. The amendment transfers responsibility for providing sidewalk infill along South 204th Street from the City to Sound Transit and eliminates the associated mitigation payment to the City by Sound Transit.

Concurrent with negotiation of the term sheet for alternative mitigation measures, the Agreement required the parties to work together and determine which federal provisions should be incorporated in subsequent agreements or amendments. Sound Transit and City staff have made this determination, and the amendment incorporates the necessary federal provisions.

Environmental compliance pursuant to the National Environmental Policy Act (NEPA) and the State Environmental Policy Act (SEPA) for Airport Link was completed with the Central Link Final Environmental Impact Statement (EIS) issued in November 1999, the Tukwila Freeway Route Final Supplemental EIS issued in November 2001, Airport Link Environmental Assessment/SEPA Addendum (EA) on May 26, 2005, and a NEPA Re-evaluation and SEPA Addendum to the EA (July 2011). The FTA issued a Record of Decision for Airport Link on September 13, 2005.

FISCAL INFORMATION

The 2013 TIP for the S. 200th Link Extension is \$383.2 million. Within that amount \$5,963,000 has been set aside for Mitigation in the Construction phase. Of this amount \$2,605,300 has been previously committed. The proposed action would increase commitments by \$2,989,700 to a revised total of \$5,595,000 for this line item, and leave a remaining budget balance of \$368,000.

This action is within the adopted budget and sufficient monies remain after approval of this action to fund the remaining work in the Construction phase as contained in the current cost estimates.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute an amendment to the Development and Transitway Agreement with the City of SeaTac for the South 200th Link Extension in the amount of \$2,989,700, for a new total authorized amount not to exceed \$6,432,000.

BACKGROUND:

The City's codes require high-capacity transit (HCT) projects to provide improvements to pedestrian and bicycle transportation networks in the HCT station area based on an assessment of access to the station. The Agreement defines the pedestrian improvements that the project will fund or provide directly. The amendment transfers responsibility for providing sidewalk infill along South 204th Street from the City to Sound Transit and eliminates the associated mitigation payment to the City by Sound Transit. This work will reduce mitigation payments to the City by \$410,300.

Concurrent with negotiation of the term sheet for alternative mitigation measures, the Agreement required the parties to work together and determine which federal provisions should be

incorporated in subsequent agreements or amendments. Sound Transit and City staff have made this determination, and the amendment incorporates the necessary federal provisions.

Environmental compliance pursuant to the National Environmental Policy Act (NEPA) and the State Environmental Policy Act (SEPA) for Airport Link was completed with the Central Link Final Environmental Impact Statement (EIS) issued in November 1999, the Tukwila Freeway Route Final Supplemental EIS issued in November 2001, Airport Link Environmental Assessment/SEPA Addendum (EA) on May 26, 2005, and a NEPA Re-evaluation and SEPA Addendum to the EA (July 2011). The FTA issued a Record of Decision for Airport Link on September 13, 2005.

MOTION:

It is hereby moved by the Board of the Central Puget Sound Regional Transit Authority that the chief executive officer is authorized to execute an amendment to the Development and Transitway Agreement with the City of SeaTac for the South 200th Link Extension in the amount of \$2,989,700, for a new total authorized amount not to exceed \$6,432,000.
