PROPOSED ACTION

Authorizes the chief executive officer to execute a five-year contract with Securitas Security Services USA, Inc. to provide system-wide security services for a total authorized contract amount not to exceed \$41,422,000.

KEY FEATURES SUMMARY

- This contract provides security services for 45 facilities in King, Pierce and Snohomish counties and for Sounder, Link and Tacoma Link services. This contract excludes security for facilities and service covered by existing partner agreements, i.e. the Downtown Seattle Transit Tunnel, Tacoma Dome Station and ST Express bus service.
- This contract provides security services based on forecasted increases in ridership and facilities expansion through 2018. Services provided in this contract include transit security, fare enforcement and Security Operation Center (SOC) operations based on an approved schedule and set rates.
- This contract allows for additional unscheduled and incidental special services when required for special events and other short-term coverage needs.
- This contract will be effective on September 1, 2013.

BACKGROUND

Sound Transit's security program consists of three parts: Sound Transit's Security Division; Sound Transit Police provided by the King County Sheriff's Office; and Sound Transit's contracted security provider. The contracted security provider is responsible for delivering security staff and services in three areas:

- <u>Transit Security Unit</u> provides customer service, inspection of critical infrastructure, uniformed presence and patrols for Sounder, Tacoma Link, and Central Link and ST Express facilities.
- <u>Fare Enforcement Unit</u> provides customer service, security and fare inspection on Central Link and Sounder service.
- <u>SOC</u> provides 24/7 dispatch and security phone response for Sound Transit customers and employees with safety or security concerns. The SOC also serves as a hub for information to Station Agents and Security personnel during service interruptions and monitors CCTV and Customer Emergency Call Stations.

This five-year contract provides Sound Transit service through the opening of the University Link Extension in 2016 and forecasted increases in ridership in 2017-18.

Securitas Security Services USA, Inc. was selected through a competitive process to provide system-wide security services not covered by existing agreements with partner agencies. A Request for Proposal (RFP) was issued in February 2013. Seven proposals were submitted. Two

were invited to resubmit a revised proposal and costs. Securitas Security Services USA, Inc. was selected as the proposer that will provide the best quality service at the best value to Sound Transit.

FISCAL IMPACT

The proposed action will be funded from Service Delivery modal budgets including Sounder Commuter rail, ST Express bus, Central, Tacoma Link light rail and Operations Department budget. Estimated expenditure for 2013 is \$2.5 million and is within the financial capacity of the 2013 Service Delivery and Department security and safety budget.

Estimated costs for the future years will be included in the future annual budgeting process.

SMALL BUSINESS PARTICIPATION

Proposers were not asked to prepare a plan for the participation of M/W/DBE or other small businesses as subcontractors. It was determined that subcontracting was not feasible as it was not in the best interest of Sound Transit to have more than one contractor provide services under the security contract.

TIME CONSTRAINTS

A delay in approval of this contract could result in a shortened time frame for the selected contractor to mobilize staff, equipment, supplies and required submittals relative to the expiration of the current security contract. A delay would necessitate an extension of the current security contract for up to three months.
