PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Motorola Solutions Inc. to purchase radio communication equipment in the amount of \$301,778, with a 10% contingency of \$30,178, for a total authorized contract amount not to exceed \$331,956, contingent upon Board approval of an agreement with King County for use of the Regional 800 MHz trunked radio system.

KEY FEATURES SUMMARY

- Under this contract, Motorola will provide three 800 MHz radio consoles, 70 hand-held radios, 13 vehicle mounted radios, and various radio accessories for use by Sound Transit personnel.
- Board action is being requested through Motion No. M2013-71 to authorize an agreement with the King County Radio Communications Services Board to allow Sound Transit to utilize the 800 MHz trunked radio system.
- This equipment will allow Sound Transit to use the 800 MHz interoperable public safety radio network in King, Pierce, and Snohomish Counties.
- Motorola is the only equipment compatible with King County's proprietary Motorola radio system. Sound Transit is piggy-backing on a Western States Contracting Alliance (WSCA) contract with Motorola for this procurement.

BACKGROUND

Sound Transit will purchase radio communication equipment through an existing contract between Motorola and the WSCA that offers direct purchase opportunities to state and local governments. Purchases made through this contract offer advantageous pricing compared to purchasing the equipment from Motorola directly or through third parties.

The contract with Motorola was competitively bid using WSCA's contracting standards. Twenty eight bids were reviewed with Motorola being granted the contract.

The Adopted 2013 Budget includes \$340,000 for the initial equipment purchase of radio communication equipment and the first year of service and maintenance.

FISCAL IMPACT

This action would be funded from the Adopted 2013 Transit Improvement Plan (TIP) for the Security Radio project. The lifetime project budget is \$340,000. Within that amount, \$305,000 has been set aside for construction phase. The proposed action would increase commitments for this line item to \$332,000 and result in a budget shortfall of \$27,000. The shortfall would be funded from the Agency Administration phase.

In summary, this action is within the adopted lifetime project budget and sufficient monies remain after approval of this action to fund any miscellaneous project costs.
