## PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with HDR Engineering, Inc. to provide professional services for Phase 2 of the Federal Way Transit Extension in the amount of \$8,835,865, with a 10% contingency of \$883,587, totaling \$9,719,452, for a total authorized contract amount not to exceed \$13,239,915.

# **KEY FEATURES SUMMARY**

- This action amends the consultant services contract for the light rail project development process to authorize Phase 2 work including preparation of a Draft Environmental Impact Statement (EIS) and conceptual engineering of alternative alignments and stations as developed through an alternatives analysis and identified by the Board in a separate motion.
- The contract with HDR Engineering, Inc. (HDR) included an option to negotiate the scope and cost for completion of Phases 2 and 3 of the light rail project development process. HDR has satisfactorily completed Phase 1 and authorization is sought to proceed to Phase 2. Authorization for Phase 3 will be sought separately in a future amendment to this contract.
- Phase 2 activities are expected to take approximately 18 months. Completion of all three phases is anticipated by 2016.

#### **BACKGROUND**

The Federal Way Transit Extension extends from the future Angle Lake Link light rail station at South 200<sup>th</sup> Street in SeaTac to the Federal Way Transit Center area in Federal Way. The project scope includes Alternatives Analysis, Draft and Final EIS, and conceptual engineering. The project scope also includes preliminary engineering for the 2.3-mile segment from South 200th Street to Kent/Des Moines and options to extend the scope of preliminary engineering farther south. Currently, there is projected funding to construct to Kent/Des Moines in the vicinity of Highline Community College. Service to Kent/Des Moines is planned to begin in 2023.

The development process of the project has three phases. Phase 1 included alternatives analysis and environmental scoping. Phase 2 includes the preparation of a Draft Environmental Impact Statement (EIS) and conceptual engineering of alternative alignments and stations as identified through the alternatives analysis and scoping processes. Phase 3 will include the preparation of a Final EIS, including responses to public and agency comments on the Draft EIS, and preliminary engineering of the project to be built.

To maintain eligibility for potential federal funding, the project will comply with the requirements of the National Environmental Policy Act (NEPA). As the public agency proposing the project, Sound Transit is required to comply with the State Environmental Policy Act (SEPA). A decision to identify

alternatives for detailed study in the Draft EIS is part of separate motion for Board consideration. Following Board action on the alternatives for detailed study in the Draft EIS, HDR will begin preparation of the Draft EIS and conceptual engineering of alternative alignments and stations.

The specific alignments, station locations, and station development programs for each alternative will be defined at the beginning of Phase 2 work. Alternatives will be defined in enough detail to allow the impacts and benefits to be identified and compared consistent with NEPA and SEPA requirements. Outreach activities will be conducted to support the definition of alignments and the environmental analysis.

HDR has satisfactorily completed Phase 1 work and was invited to negotiate the scope of work and cost for the Phase 2 Draft EIS and conceptual engineering. This contract amendment approves the Phase 2 consultant services scope of work and adds funds to complete it.

## **FISCAL IMPACT**

This action is within the Adopted Budget and sufficient funds remain after approval of this action to fund the remaining work in the Preliminary Engineering Phase as contained in the current adopted budget.

### **MOTION NO. M2013-78**

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a contract amendment with HDR Engineering, Inc. to provide professional services for Phase 2 of the Federal Way Transit Extension in the amount of \$8,835,865, with a 10% contingency of \$883,587, totaling \$9,719,452, for a total authorized contract amount not to exceed \$13,239,915.

#### **BACKGROUND:**

The Federal Way Transit Extension extends from the future Angle Lake Link light rail station at South 200<sup>th</sup> Street in SeaTac to the Federal Way Transit Center area in Federal Way. The project scope includes Alternatives Analysis, Draft and Final EIS, and conceptual engineering. The project scope also includes preliminary engineering for the 2.3-mile segment from South 200th Street to Kent/Des Moines and options to extend the scope of preliminary engineering farther south. Currently, there is projected funding to construct to Kent/Des Moines in the vicinity of Highline Community College. Service to Kent/Des Moines is planned to begin in 2023.

This contract amendment approves the Phase 2 consultant services scope of work and adds funds to complete it.

Phase 2 work includes preparation of a Draft Environmental Impact Statement (EIS) and conceptual engineering of alternative alignments and stations as developed through an alternatives analysis and identified by the Board in a separate motion. Phase 2 activities are expected to take approximately 18 months. Completion of all three phases is anticipated by 2016.
