PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Huitt-Zollars to provide additional design services for Phase 3 work for the South 200th Link Extension in the amount of \$2,078,127, with a 10% contingency of \$207,813, totaling \$2,285,940, for a total authorized contract amount not to exceed \$12,972,928.

KEY FEATURES SUMMARY

- The contract amendment would fund additional Phase 3 tasks that are within contract scope but were not previously included in the work. This work includes:
 - Design of traffic signal and channelization improvements in WSDOT rights-of-way at S. 200th Street and Military Road S.
 - Development of 60% designs for both baseline and alternative mitigations for the station area roadways contract package.
 - Additional environmental investigation and documentation required by the discovery of two ditches possibly under the US Army Corps of Engineers' jurisdiction.
 - o Design services during construction (DSDC) for station area roadways work.
 - o Additional administrative support for the guideway and station design-build contract.
 - o Extension of management services to December 2016 to support the contract.
- Phase 3 work began in February 2013 and included design services for the South 200th Link Extension parking garage (including potential transit-oriented development around the garage), station area roadways and support for the Angle Lake station and guideway design-build contract.

BACKGROUND

The South 200th Link Extension will extend light rail approximately 1.6 miles from SeaTac/Airport Station to Angle Lake Station, spanning South 200th Street. The design features an elevated light rail guideway, an elevated station, and a detached park-and-ride facility with long-term capacity of approximately 700 stalls. The interim capacity of the park-and-ride facility will be up to 1,100 stalls while Angle Lake Station is a temporary southern terminus of the light rail system. Station amenities include on-street bus pullouts at the station, an off-street passenger drop-off area, secured bicycle parking, and improved pedestrian and bicycle connections in the station vicinity.

In September 2010, the Board authorized a contract with Huitt-Zollars (Motion No. M2010-76) to provide civil, architectural, and systems design services to refine previous preliminary engineering work on the South 200th Link Extension guideway and Angle Lake Station. A refined alignment plan and profile and updated cost estimate were produced.

Phase 1 work refined the preliminary engineering work done under Sound Move to allow consideration of accelerating the extension to South 200th Street. Work tasks included

geotechnical investigations, civil and systems engineering, coordination of the track alignment with planned future roadways on Port of Seattle property, station architecture, cost estimating, noise analysis, surveying, mapping, utility engineering, and facilitating design-build workshops. Phase 1 work tasks are now complete.

Phase 2 work advanced the design of the guideway and Angle Lake Station enough to pursue a Conditional Use Permit and Development Agreement with the City of SeaTac. It also advanced systems engineering design, assisted Sound Transit in developing the design-build procurement documents for the guideway and station, including an RFQ/RFP for final design and construction, and supported Sound Transit's evaluation of cost and technical proposals from the design-build proposers. The agency also received assistance with right of way engineering and surveying, sustainability evaluation, permitting support, and illustrative design graphics during Phase 2. Phase 2 work tasks are now complete.

Phase 3 work began in February 2013. The scope included assisting Sound Transit with the remaining South 200th Link Extension contract packages identified at that time, the parking Garage with potential adjacent transit-oriented development, station area roadways, and support of the station and guideway support design-build contract.

Phase 3 work completed to-date has revealed the need for additional tasks and allows Sound Transit to define with greater assurance services needed to complete the project. This work includes:

- Design work for traffic signal and channelization improvements at the intersection of S. 200th St, Military Rd S, and I-5 to satisfy required mitigation measures under the Development and Transitway Agreement with the City of SeaTac. This work was previously anticipated to be performed by WSDOT because it is wholly within WSDOT limited access ROW; however WSDOT has determined that they do not have adequate resources to perform this work to meet Sound Transit's schedule.
- Development of 60% designs for both baseline and alternative mitigations for the station area
 roadways contract package. Preparation of 60% designs for both potential mitigation scenarios
 is recommended to reduce schedule risk if the City of SeaTac is unsuccessful in implementing
 its proposed alternative mitigation project. Only one of the two 60% designs will be carried to
 100%, following the City's performance or non-performance in demonstrating secured
 construction funding for its project by August 15, 2014.
- Additional environmental investigation and documentation required by discovery of a ditch that
 will fall under US Army Corps of Engineers jurisdiction, and additional environmental review for
 traffic signal and channelization improvements in WSDOT rights-of-way and, potentially, the
 station area roadways contract package that was not previously anticipated.
- Design Services During Construction (DSDC) for station area roadways work. The work was not adequately defined under previous contract amendments.
- Additional administrative support for the guideway and station design-build contract because
 the previous allowance for the station design-build contract support was exhausted in support
 of real estate acquisition efforts.
- Extension of management services to December 2016 to support the contract, including the additional work described above.

FISCAL IMPACT

The 2013 TIP for the S. 200th Link Extension is \$383.2 million. Within that amount:

- \$6,810,648 has been set aside for the Final Design phase. The proposed action will result in a phase budget shortfall of \$1,937,591. The transfer of budget funds to this phase from the Construction phase has been included in the Proposed 2014 TIP.
- \$4,741,448 has been set aside for Design-Build Preparation in the Final Design phase. An additional \$1,347,483 was authorized by the Sound Transit Board in January 2013 (Motion M2013-02) for a total commitment of \$6,088,931.
- The proposed action would increase the commitment for this line item by \$2,285,940 to a total of \$8,374,371, and increase the budget shortfall by that amount to \$3,633,423. The additional shortfall will be funded from surplus budget within the Construction phase.

This action is within the adopted budget and sufficient monies remain after approval of this action to fund the remaining work in the project as contained in the current cost estimates.

SMALL BUSINESS PARTICIPATION

Huitt-Zollars is the prime consultant for this contract. The actual Small Business participation achieved will vary depending on the needs of the additional Phase 3 work and cannot be definitively detailed at this time. However, Huitt-Zollars is committed to distributing the work to the subconsultant firms as necessary to provide the services as required. This amendment will fund work of which 14.7% is expected to be assigned to subconsultants who are identified as small or disadvantaged businesses.

The Small Business participation goal established for this contract is 13%. Performance to date is 17% Small Business and Disadvantaged Business participation for Phase 1, 2 and 3 design refinement services.

TIME CONSTRAINTS

A one month delay would decrease project float impacting final design and construction schedules, and would delay achievement of intermediate design milestones for station area roadways and mitigation within WSDOT rights-of-way.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a contract amendment with Huitt-Zollars to provide additional design services for Phase 3 work for the South 200th Link Extension in the amount of \$2,078,127, with a 10% contingency of \$207,813, totaling \$2,285,940, for a total authorized contract amount not to exceed \$12,972,928.
