GC/CM Pre-construction Services Contract for Roosevelt Station Finishes within the Northgate Link Extension

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with Hoffman Construction Company to provide pre-construction services for Roosevelt Station Finishes within the Northgate Link Extension in the amount of \$1,248,150, with a 10% contingency of \$124,815, for a total authorized contract amount not to exceed \$1,372,965.

KEY FEATURES SUMMARY

- The proposed contract uses the General Contractor/Construction Manager (GC/CM)
 alternative contracting procedure. The GC/CM delivery approach was selected for this
 procurement when Northgate Link Extension baseline scope, schedule, and budget was
 approved and was based on certain project characteristics including complex scheduling
 and phasing requirements and extensive interface with other contractors.
- Pre-construction services for the Roosevelt Station Finishes work include:
 - Participating in development of final project management and construction plans
 - Construction scheduling and subcontracting plans
 - Development of cost estimates for station construction
- o Risk management
- Safety and quality plans
- Building Information Modeling
- Small business and Disadvantaged Business Enterprise outreach plans
- Value engineering
- Constructability reviews
- Following pre-construction phase activities, Sound Transit will negotiate a Maximum Allowable Construction Cost (MACC) with Hoffman Construction Company which will be the basis for award of the GC/CM construction contract.
- Pre-construction services will last approximately 21 months and are concurrent with the final design of the Roosevelt Station. If MACC negotiations are successful, the construction contract to build the station facility will be brought to the Board for approval.

BACKGROUND

The Northgate Link Extension extends light rail approximately 4.3 miles from the University of Washington Station to the Northgate neighborhood. The Roosevelt Station is located on 12th Avenue NE and NE 65th Street and is one of two underground stations for the Northgate Link Extension. The Northgate Link Extension is scheduled to be completed in September 2021 and will provide an interim terminus for Link light rail at Northgate until the Lynnwood Link Extension is operational, currently anticipated in 2023.

Initial Northgate Link construction work for building demolition and hazardous materials abatement and advanced utility relocations at Roosevelt Station began in 2012 and was completed in August 2013.

The Roosevelt Station Finishes contract will be Sound Transit's fourth construction contract using the GC/CM contracting method, an alternative method allowed under RCW 39.10 and utilized successfully on three University Link contracts. The Project Review Committee of the State's Capital Project Advisory Review Board approved the GC/CM method for this work in September 2012. The GC/CM method of contracting involves contractor selection based on qualifications and pricing for specific project elements.

A Request for Qualifications was issued in April 2013 and five Statements of Qualifications (SOQs) were received. Following review and evaluation, three firms were invited for interviews. Based on scoring of the SOQs and the interviews, all three firms were asked to submit final proposals including price offers for specified work items. The price offers were opened publicly on August 14, 2013. Based on evaluation of SOQs, interviews, and price offers, Hoffman Construction was the highest ranked firm.

Consistent with the GC/CM process, following completion of pre-construction services, Sound Transit will negotiate a MACC with the contractor. If a MACC is agreed to, it is anticipated that Board approval will be requested to execute a construction contract with Hoffman Construction Company under which they will construct the Roosevelt Station Finishes, including the station structure, architectural finishes, mechanical components and electrical equipment. That contract is anticipated to be complete in 2019. If an agreement on the MACC cannot be reached, Sound Transit will have the option of bidding the work through a traditional invitation for bids (IFB) or entering cost negotiations with the second ranked team.

FISCAL IMPACT

The 2013 TIP for the Northgate Link Extension is \$2.131 billion. Within that amount \$2,960,000 has been set aside for GC/CM Preconstruction within the Construction Services phase. The proposed action would commit \$1,389,000 for this line item, leaving a remaining budget balance of \$1,587,035.

This action is within the adopted budget and sufficient monies remain after approval of this action to fund the remaining work in the Construction Services phase as contained in the current cost estimates.

A motion of the Capital Committee of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to execute a contract with Hoffman Construction Company to provide pre-construction services for Roosevelt Station Finishes within the Northgate Link Extension in the amount of \$1,248,150, with a 10% contingency of \$124,815, for a total authorized contract amount not to exceed \$1,372,965.

BACKGROUND:
