PROPOSED ACTION

Authorizes the chief executive officer to increase the contingency for the contract with CA Carey Corporation to provide construction services for the Mukilteo Station – South Platform project in the amount of \$1,100,000, for a new total authorized contract amount not to exceed \$8,145,500.

KEY FEATURES SUMMARY

- The proposed action increases the contract contingency to cover costs associated with the delay in the start of field work including extended overhead, additional material storage and handling, and assignment of work to a new subcontractor. The contract contingency will also fund changes to shoring, temporary crossings, and the platform substructure. These are adjustments that the final design team had to revise to meet the revised BNSF requirements.
- The proposed action will maintain adequate contingency for the balance of the contract work.
- The substantial completion date of the contract will be extended from Winter 2014 to Spring 2015.

BACKGROUND

The Mukilteo Sounder Station is divided into two projects: the north platform and the south platform. The north platform and parking lot have been in operation since 2008. The south platform project includes construction of the south-side platform, stairs, elevator towers for both platforms, and a pedestrian bridge connecting the two platforms. Other amenities include passenger shelters, benches, bicycle lockers, closed circuit television, and ticket vending machines.

The south platform will be located on BNSF right-of-way adjacent to the tank farm property and east of the Mukilteo Speedway. It is being developed in coordination with future WSDOT plans for a new ferry terminal and redevelopment plans for the tank farm property.

Some of the south platform improvements, including the overhead pedestrian walkway, will be constructed on the tank farm property. Ownership of this property was transferred from the United States Air Force to the Port of Everett in September 2013. Included in the transfer was an assumption of a lease to Sound Transit, allowing use of the tank farm property for the south platform improvements.

Sound Transit issued a notice-to-proceed to CA Carey Corporation in May 2013. As station construction began, discussions were held with the contractor and BNSF regarding construction requirements. Due to the length of those discussions, the time required for BNSF to install the

temporary track crossings, and a BNSF moratorium on construction in the area during the fourth quarter of 2013, field construction work did not begin until January 2, 2014.

As part of those discussions, it was determined that changes would need to be made to reduce construction impacts in the vicinity of BNSF-owned tracks. These changes included redesigning the temporary shoring for the elevator pit to reduce risks and impacts to the railroad and redesigning the platform substructure to eliminate shoring requirements along the length of the platform. These changes will enable the project to move forward and reach substantial completion by Spring 2015.

FISCAL IMPACT

The 2014 Lifetime TIP for the Mukilteo Station – South Platform is \$18,312,899. Within that amount, \$9,040,476 has been set aside for the Construction phase, of which \$7,045,500 has been committed for the CA Carey Corporation contract. The proposed action would commit an additional \$1,100,000 for this contract. Any budget shortfall will be funded using the Construction Unallocated Contingency. This leaves a remaining uncommitted balance of \$445,635 in the Construction phase.

This action is within the adopted budget and sufficient monies remain in the Construction phase after approval of this action to fund the remaining work as contained in the current cost estimates.

A motion of the Board of the Central Puget Sound Regional Transit Authority authorizing the chief executive officer to increase the contingency for the contract with CA Carey Corporation to provide construction services for the Mukilteo Station – South Platform project in the amount of \$1,100,000, for a new total authorized contract amount not to exceed \$8,145,500.

BACKGROUND:

The Mukilteo Sounder Station is divided into two projects: the north platform and the south platform. The north platform and parking lot have been in operation since 2008. The south platform project includes construction of the south-side platform, stairs, elevator towers for both platforms, and a pedestrian bridge connecting the two platforms. Other amenities include passenger shelters, benches, bicycle lockers, closed circuit television, and ticket vending machines.

The south platform will be located on BNSF right-of-way adjacent to the tank farm property and east of the Mukilteo Speedway. It is being developed in coordination with future WSDOT plans for a new ferry terminal and redevelopment plans for the tank farm property.

Some of the south platform improvements, including the overhead pedestrian walkway, will be constructed on the tank farm property. Ownership of this property was transferred from the United States Air Force to the Port of Everett in September 2013. Included in the transfer was an assumption of a lease to Sound Transit, allowing use of the tank farm property for the south platform improvements.

Sound Transit issued a notice-to-proceed to CA Carey Corporation in May 2013. As station construction began, discussions were held with the contractor and BNSF regarding construction requirements. Due to the length of those discussions, the time required for BNSF to install the temporary track crossings, and a BNSF moratorium on construction in the area during the fourth quarter of 2013, field construction work did not begin until January 2, 2014.

As part of those discussions, it was determined that changes would need to be made to reduce construction impacts in the vicinity of BNSF-owned tracks. These changes included redesigning the temporary shoring for the elevator pit to reduce risks and impacts to the railroad and redesigning the platform substructure to eliminate shoring requirements along the length of the platform.
