Contract Amendment with Parsons Brinckerhoff, Inc. for Planning Services for Development of Regional High Capacity Transit System Plan

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Parsons Brinckerhoff, Inc. to provide planning services for development of a regional high capacity transit system plan in the amount of \$5,676,607, with a 10% contingency of \$567,661 totaling \$6,244,268, for a new total authorized contract amount not to exceed \$11,007,810.

KEY FEATURES SUMMARY

- This contract will assist Sound Transit in the development of a regional high capacity transit system plan of transit investments to take to voters in 2016. The development of the plan is based on the updated Long-Range Plan and will consider projects and corridors included in the Long-Range Plan.
- The contract scope of work includes:
 - o Project management and administration
 - o Methodologies development and documentation
 - Transit service integration planning
 - o Ridership forecasting analysis support
 - System expansion alternatives development
 - Project definition/screening
 - System expansion alternatives testing and evaluation
 - o Further issue paper development and application within system planning
 - Financial planning support
 - System plan documentation
 - System plan approval support
- The contract period extends through December 2016, but may be extended based on Board direction regarding the development of a Regional High Capacity Transit System Plan.

BACKGROUND

As approved by the Board, a three-stage approach will be used to develop a plan for the next phase of investments by 2016:

0	HCT corridor studies	2013-2014
0	Long-Range Plan update with SEPA environmental review	2013-2014
0	Development of the next phase of the Regional HCT System Plan	2015-2016

In 2013, the Board authorized a contract with Parsons Brinkerhoff, Inc. to provide planning services related to updating the 2005 Regional Long-Range Plan and preparing a programmatic SEPA environmental impact statement. The contract also included an option for a third stage to develop the next phase of the Regional HCT System Plan.

The agency uses both a long-range plan and a regional HCT system plan to guide the planning process for development and expansion of the high capacity transportation system. A long-range plan presents a comprehensive view of the region's needs and a general vision for meeting these needs.

A plan-level environmental impact statement (EIS) was completed to inform the update to the Long-Range Plan. Project-specific environmental analysis will be completed for projects included in the System Plan, after approval of a ballot measure to fund the implementation of the plan.

The Long-Range Plan includes an extensive list of potential projects and corridors that can be considered during the development of the system plan. The high capacity transit corridor studies completed over the last year will inform the process.

This contract will assist Sound Transit in the development of a regional high capacity transit system plan of transit investments to take to voters in 2016. The development of the plan is based on the updated Long-Range Plan and will consider projects and corridors included in the Long-Range Plan. The system plan is financially and time-constrained and funding must be approved by voters.

An extensive level of public involvement will be implemented as part of the development of the system plan to obtain public, agency and jurisdiction input.

FISCAL INFORMATION

The 2014 Proposed Lifetime Budget for ST3 Planning project is \$39,200,000. Within that amount, \$36,200,000 has been set aside for the Preliminary Engineering Phase, of that amount \$6,643,037 has been previously committed for the Preliminary Engineering Phase.

The proposed action would commit and additional \$6,244,268 for a contract amendment with Parsons Brinckerhoff, Inc., leaving the remaining uncommitted budget of \$23,312,694 in the Preliminary Engineering Phase.

This action is within the Adopted Budget and sufficient funds remain after approval of this action to fund the remaining work in the Preliminary Engineering Phase as contained in the current cost estimates.
