PROPOSED ACTION

Authorizes the chief executive officer to execute an agreement amendment with King County to provide an On-Board Systems Communications System and Transit Radio System in the amount of \$567,269 for a new agreement amount not to exceed \$3,267,269.

KEY FEATURES SUMMARY

- This agreement amendment covers Sound Transit's proportionate share of costs for King County's On-Board Mobile Communications system.
- The mobile communications system provides the infrastructure and equipment for radio communication, Computer Aided Dispatch/Automatic Vehicle Locator, and Automatic Passenger Counters (APCs), and is necessary for Sound Transit buses to maintain compatibility with King County fleet operations.
- This amendment covers cost increases from King County Metro's initial estimate. Following the
 completion of design, the project management team determined that additional components would
 be necessary for the system to work properly. In addition, installation required more labor hours
 than was budgeted for in the project.
- The system is currently in the final stages of testing and acceptance.

BACKGROUND

The original agreement with King County was to equip 117 Sound Transit buses with an on-board communications system. It was negotiated and signed on December 19, 2008. Over the past six years, there have been a number of changes in technology and in Sound Transit's fleet based at KCM that resulted in changes to the agreement. The most significant change was the decision by King County to add Mobile Access Routers to the project after the original scope of work was developed. These routers allow "next bus" capabilities at major bus stop kiosks and improve communication capabilities in the Downtown Seattle Transit Tunnel. This amendment covers the purchase and installation of those Mobile Access Routers on each Sound Transit bus as well as underestimated labor hours necessary to install and test the entire system.

The original agreement provided for King County to purchase and install the Computer Aided Dispatch/Automatic Vehicle Locator (CAD/AVL) systems on all 117 ST buses and Automatic Passenger Counters (APC) on 25% of Sound Transit's fleet. The CAD/AVL system is necessary for Sound Transit buses to maintain compatibility with King County fleet operations and dispatch. The APCs provide accurate passenger counts. This amendment also includes six additional APC units to cover Sound Transit's request that all new buses have APCs installed on them.

FISCAL INFORMATION

The proposed action will be funded from the unallocated budget of construction phase of Project 745 – ST Express Mobile Communications.

The 2014 lifetime budget of the construction phase is \$10,531,027. Within that amount, the Board has approved three agreements:

Pierce Transit - \$5,720,000 project completed.

Community Transit - \$1,456,585 project near completion and costs will come in at the budget. King County Metro - \$2,700,000.

The proposed action will increase the agreement with King County by \$567,269, bringing the total of agreement amount to \$3,267,269.

Upon the approval of this action, the total board approvals will be \$10,443,786, leaving \$87,000 of unallocated funds.
