Contract Amendment for Technology Hardware and Hardware Maintenance Services

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Dell, Inc. to provide technology hardware and hardware maintenance services in the amount of \$80,000, for a total authorized contract amount not to exceed \$980,000.

KEY FEATURES SUMMARY

- Work outlined in this contract amendment includes:
 - The replacement of aging hardware;
 - The purchase of new hardware for approved agency projects for Sound Transit FTEs and consulting staff; and
 - Maintenance renewals for servers and disk storage units.
- Sound Transit is using a piggy-back contract with the Western States Contracting Alliance (WSCA) Master Price Agreement and Washington State Department of Information Services addendum with Dell Marketing LP for these services.
- Using the WSCA contract allows Sound Transit to take advantage of a 15% to 40% discount afforded by this multi-agency procurement mechanism.
- Sound Transit has procured technology hardware through a similar method for the past ten years, each with an annual piggy-back contract to cover the year's expected expenses.

BACKGROUND

This request is being made as Western States Contracting Alliance (WSCA) has extended the existing contract through 2014. We are estimating that a new contract will be in place by January 2015, at which point we will return to the Board to request approval of the new contract.

This contract includes sufficient funds to cover the rest of 2014 to procure workstations for employees and co-located consultants needing new hardware to replace expiring workstations, as well as new hardware for additional positions expected to be filled in early 2015. This contract also includes funds for maintenance renewals on server hardware required to support approved technology projects.

The maintenance services portion of the contract includes 24-hour support for servers, parts, and software replacement, with a four-hour response time. Maintenance for workstations, laptops, and monitors includes 24-hour support with next business day parts replacement.

The Western States Contracting Alliance (WSCA) allows states to join together in cooperative multi-state contracting in order to achieve cost-effective and efficient acquisition of quality products and services. These contracting initiatives are administered by a western region state and follow a review process managed by the state directors from the western region. Additionally, Sound Transit staff have verified the competitiveness of the prices contained within the contract.

FISCAL IMPACT

The proposed action seeks to add \$80,000 in additional contract authority to purchase Dell Computer equipment. Budget authority for the 2014 portion of the original Dell contract was budgeted in the Finance and Information Technology budget and in the Information Technology Program budget. This request will use the FIT budget for all remaining Dell computer equipment purchases and an uncommitted balance of \$366,165 will be available in the budget after funds are committed through this action.

This action is within the adopted budget and sufficient monies remain after approval of this action to fund the remaining computer equipment purchases.

Because this contract piggy-backs onto the Western States Contracting Alliance (WSCA) contract for Dell, Inc., goals for participation were not established by Sound Transit.

A one month delay would impact support services from the vendor.
