PROPOSED ACTION

Authorizes the chief executive officer to execute a one-year contract with three one-year options with Management Services Northwest, Inc., to provide agency-wide janitorial services for a total authorized contract amount not to exceed \$4,165,000.

KEY FEATURES SUMMARY

- The contract covers comprehensive janitorial services for all Tacoma Link stations and Tacoma Link light rail vehicles, Sounder stations, ST Express bus facilities maintained by Sound Transit, and Union Station.
- The contract scope of work includes daily, monthly, and semi-annual janitorial services performed on an approved schedule with set rates and unscheduled work that must be authorized by work order.
- This contract includes provisions to add new stations as they are completed.
- The requested amount will cover the one-year contract and all three option years.

BACKGROUND

Sound Transit has 41 facilities and three Tacoma Link revenue service vehicles that require daily, monthly, quarterly and semi-annual services. The facilities include Sounder commuter rail, Tacoma Link light rail and ST Express bus facilities located in Pierce, King and Snohomish counties as well as Sound Transit's headquarters at Union Station. Central Link facilities are maintained under a third party agreement administered by King County Metro, so they are not included in this contract.

The scope of work includes cleaning of office space, warehouse office space, external walkways, plazas, train platforms, pedestrian bridges, garages, parking lots, bus loops and shelters, elevators, bike lockers, Tacoma Link light rail vehicles, and services for day porter, special event porter (Great Hall), snow removal and de-icing.

A Request for Proposals for Sound Transit janitorial services was issued March 26, 2015. Two proposals were received. Management Services Northwest, Inc. was determined to be the top ranked proposer and the company that offers the best value to Sound Transit. Their proposal price came in 9.4% less than Sound Transit's independent cost estimate.

To ensure environmental safety, the contractor is required to use green cleaning products to reduce Sound Transits chemical foot print. Management Services Northwest has a strong commitment to protecting the environment.

FISCAL INFORMATION

The proposed action will be funded from Facilities Maintenance budget within the 2015 Sounder, ST Express and Tacoma Link operating budget. Janitorial Services for Union Station will be funded from Service Budget within the 2015 Operations Department operating budget. The proposed contract will charge expense against various funding source based on the location the services are performed. 2015 estimated costs of \$840 thousand are within the budget authority, with approximately \$3.2 million remaining in the 2015 budget for other station maintenance services.

Spending for future years during the life of the contract will be included in the annual budgeting cycle.

Sound Transit determined that Small Business and DBE subcontracting opportunities are infeasible or improbable based upon the work described in this contract, so Small Business/DBE goals were not established. Management Services Northwest is a Small Business.

PUBLIC INVOLVEMENT

Not applicable to this action.

TIME CONSTRAINTS

A short term delay of up to one month will not impact the Facility Maintenance Division's ability to maintain Sound Transit facilities. A Limited Notice to Proceed was issued June 1 to continue janitorial services.
