Advanced Work Package for the Northgate Station, Elevated Guideway, and Parking Garage Contract within the Northgate Link Extension

PROPOSED ACTION

Authorizes the chief executive officer to execute a contract with M.A. Mortenson Construction Company to provide construction services for the Advanced Work Package of the Northgate Station, Elevated Guideway, and Parking Garage contract within the Northgate Link Extension in the amount of \$2,076,139, with a 10% contingency of \$207,614, for a total authorized contract amount not to exceed \$2,283,753.

KEY FEATURES SUMMARY

- The Northgate Station, Elevated Guideway, and Parking Garage (N160) contract is a heavy civil General Contractor/Construction Manager contract that includes the station structure and finishes, elevated guideway, parking garage, and temporary replacement parking facilities. Pre-construction services for the N160 contract has been awarded to M.A. Mortenson Construction Company with work currently underway.
- The GC/CM is allowed to bid, award, and construct bid packages prior to receipt of final documents for the entire project. Such early work bid packages, known as "mini-MACCs", are later incorporated into the Maximum Allowable Construction Cost (MACC) for the entire contract.
- This proposed action is for a "mini-MACC" that consists of an Advanced Work Package of the N160 contract.
- The Advanced Work Package includes constructing a temporary parking area to serve as replacement parking for a portion of King County Metro's Northgate Park and Ride as well as tenant improvements to an existing Sound Transit-owned commercial building for use as the field office for Sound Transit and the N160 contractor.
- The scope of work for the Advance Work Package includes:
 - Demolition of two existing buildings;
 - Renovation of an existing building for use as a field office for GC/CM and Sound Transit staff;
 - o Grading, asphalt pavement, pavement marking, lighting and signage;
 - o Storm drainage improvements; and
 - Pedestrian pathways.
- The work duration is expected to be approximately six months and will be concurrent with preconstruction phase activities, finalizing contract documents, and negotiation of the total contract MACC.
- As work on the Advanced Work Package progresses, Sound Transit will negotiate a MACC with M. A. Mortenson Construction Company for the remaining work (station finishes, elevated guideway, and parking garage) of the N160 construction contract. If MACC negotiations are

- successful, this construction contract will be amended and be brought to the Board for approval.
- If agreement on the MACC cannot be reached, this Advanced Work Package contract will be closed after completion of replacement parking and building renovations. Sound Transit will have the option of bidding the station finishes, elevated guideway, and parking garage work through a traditional Invitation for Bids (IFB) or entering into cost negotiations with the second ranked firm.

BACKGROUND

The Northgate Link Extension extends light rail 4.3-miles from the University of Washington Station north under the campus via twin bored tunnels to an underground U District Station along Brooklyn Avenue NE between NE 43rd and NE 45th Streets, and underground Roosevelt Station along 12th Avenue NE between NE 65th Street and NE 67th Street, and continuing to an elevated station in Northgate along 1st Avenue NE spanning NE 103rd Street. The Northgate Link Extension is scheduled to be completed in September 2021 and will provide an interim terminus for Link at Northgate until the Lynnwood Link Extension is in service, currently anticipated in 2023.

The overall scope of the N160 construction contract includes the station structure (architectural finishes, mechanical and electrical elements, vertical circulation, and site improvements), elevated guideway, a permanent parking garage for approximately 450 vehicles as well as a temporary parking lot for vehicles displaced by the construction activities.

As part of pre-construction activities, the opportunity to improve overall all project schedule was identified. The Advanced Work Package tasks will allow the N160 contractor to begin construction of the Northgate Station immediately upon completion of the MACC negotiations and approval by the Board.

FISCAL INFORMATION

The lifetime budget in the 2015 Transportation Improvement Plan (TIP) for the Northgate Link Extension, as amended by resolution of the ST Board in September 2015, is \$1.895 billion. Within that amount, \$144,900,000 has been set aside for N160 Northgate Station and Guideway contract in the Construction phase. The proposed action would commit \$2,283,753 of this amount, leaving a remaining budget balance of \$142,616,247 for this line item.

This action is within the adopted budget and sufficient monies remain after approval of this action to fund the remaining work in the Construction phase of the Northgate Link Extension as contained in the current cost estimates. Use of Construction phase unallocated contingency is not required for this action.

Participation by Small Businesses and Disadvantaged Business Enterprises (DBEs)

Sound Transit promotes and encourages small business participation, which also includes Disadvantaged Business Enterprises (DBEs). Consistent with Sound Transit Policies and Federal Regulations, Sound Transit has established Small Business/DBE goals for this contract. These goals are based upon an examination of subcontracting opportunities contained in the work of this contract and the number of Small Businesses/DBEs available to perform such subcontracting work.

For N160, the following goals were set and M.A. Mortenson Construction Company has committed to the following Small Business/DBE Participation:

<u>Small Business and Disadvantaged Business Enterprise Goals</u> Commitment:

Small Business: 15%

DBE: 4%

For this "mini-MACC", small business utilization will be reflected in the overall goal established for the N160 contract.

PUBLIC INVOLVEMENT

The Northgate Link project staff has been actively engaged with stakeholders at all levels throughout the project area. The neighboring communities have had numerous opportunities to meet with staff, learn about the project and provide comments or questions.

TIME CONSTRAINTS

The proposed contract will create parking areas that permit the station and guideway footprint to be utilized for construction. A one month delay may impact start of construction for the Northgate Station, elevated guideway, and parking garage work.

PRIOR BOARD/COMMITTEE ACTIONS

Motion No. M2015-14: Authorized the chief executive officer to execute a contract with M.A. Mortenson Construction Company to provide pre-construction services for Northgate Station Finishes within the Northgate Link Extension in the amount of \$1,380,344, with a 10% contingency of \$138,034 for a total authorized contract amount not to exceed \$1,518,378.
