Motion No. M2016-43: Authorizing the chief executive officer to execute a contract amendment with David Evans & Associates to provide additional final design and design support during construction services for the Tacoma Trestle Track & Signals Project in the amount of \$2,825,763, with a 10% contingency of \$282,576, totaling \$3,108,339 for a new total authorized contract amount not to exceed \$16,251,071.

Resolution No. R2016-10: (1) Amending Resolution No. R2013-24 to maintain a fare structure for Tacoma Link light rail of \$1.00 for the Adult fare category, \$0.75 for the Youth fare category, and \$0.50 for the Senior/Disabled fare category until the start of service for the Tacoma Link Expansion project, and (2) authorizing an agreement with the City of Tacoma or designee for compensation of the net fare revenue of \$29,000 each year until Tacoma Link Expansion service begins to allow Tacoma Link service to continue to operate as fare-free.
