# **User-Centered Design Consulting Services Contract**

#### PROPOSED ACTION

Authorizes the chief executive officer to execute a three-year contract with two one-year options to extend with FCV USA, Inc. to provide User-Centered Design consulting services for a total authorized contract amount not to exceed \$1,820,000.

#### **KEY FEATURES SUMMARY**

- FCV USA, Inc. will provide User-Centered Design (UCD) consulting services that include conducting audience and user research; planning and conducting surveys, usability tests, and other user feedback tools; developing mockups and prototypes of tools; and other consulting services as needed.
- UCD consulting services will be used to develop a signage control system and tools for phase 2 of the ORCA Program.
- The contract with FCV USA, Inc. will be managed by the IT Department, but the proposed services could support the research needs of all agency divisions.
- The requested contract amount includes the initial three-year contract period. Staff will return to the Board to seek additional funding for the contract options following the initial three-year term.

#### **BACKGROUND**

Sound Transit has successfully used UCD services to help design and build the soon-to-be launched ticket vending machine interface redesign, station signage pilot project and the redesign of both the Sound Transit intranet and mobile website. These services provide valuable information about Sound Transit riders and are used to develop and design technology products to meet riders' needs.

This contract will provide UCD consulting services for development of a signage control system, ongoing improvements to the Sound Transit desktop and mobile websites, and further development of the website and other tools for Phase 2 of the ORCA program. This contract will enable UCD work on a task-order basis and could be used by any department in the agency to support research needs.

Sound Transit issued a Request for Proposal (RFP) for User Centered Design (UCD) Consulting Services and received and evaluated seven proposals. FCV USA Inc. best met the evaluation criteria, offered the best value and is in the best interest to Sound Transit.

# **FISCAL INFORMATION**

This contract is being treated as an on-call contract and task orders will be used as needed for the agency R&T Program or other projects and departments as needed. The services described in this proposed action will be assigned on an as-needed basis after available budget is verified. Since

the proposed services will be assigned on an as-needed basis, the distribution of cost will be determined as program schedules require.

The previous contract providing similar on-call services was utilized by ORCA, Signage Improvements, R&T program and the Communications and External Affairs Department (CEA).
