# **Contract Amendment for Knowledge Transfer Services**

## PROPOSED ACTION

Authorizes the chief executive officer to execute a contract amendment with Waldron Inc. for Knowledge Transfer services in the amount of \$236,500 for a new total authorized contract amount not to exceed \$386,500.

#### **KEY FEATURES SUMMARY**

- The contract with Waldron, Inc. was originally executed under the CEO's authority as a pilot program for knowledge transfer solution services in the amount of up to \$150,000.
- Sound Transit expects to complete six knowledge transfer projects by the end of July 2016 when the contract with Waldron, Inc. will end.
- A new procurement for Knowledge Transfer services is underway for a multiyear contract to provide knowledge transfer services after the expiration of this contract.
- This action would increase the existing contract with Waldron Inc. to fund the completion of four ongoing knowledge transfer projects, as well as two anticipated emergency knowledge transfer projects needed between now and the end of July 2016 to preserve knowledge from retiring employees.

#### BACKGROUND

In 2014 as part of strategic workforce planning process, HR identified a number of key divisions in the agency with deep specialized expertise and a high number of projected retirees in 2016 and beyond (almost 20% of staff). To address this talent risk in 2015 we selected Waldron, Inc. through a competitive procurement to provide Knowledge Transfer Program services to retain critical knowledge, establish a mentoring program structure and provide new employees with clear development plans for their current job as well as for future career path planning purposes.

Following the first successful pilot of that work in DECM Construction Management Team, we initiated additional knowledge transfer projects for other Sound Transit departments including IT Infrastructure, Operations, Legal and the Environmental Sustainability team. This work included two additional emergency knowledge transfer projects for two employees retiring in 2016 (Service Planning Manager and his team, and a specialized Senior Legal Counsel position).

## **FISCAL INFORMATION**

This action executes a contract amendment with Waldron, Inc. for Knowledge Transfer services for \$236,500. This action is within the adopted budget and sufficient monies remain after approval of this action to fund the remaining services as contained in the current year department budget.
