# **Items for Committee Final Action**

- A. Motion No. M2017-78: Authorizes the chief executive officer to execute a three-year contract with two one-year options with Setracon, Inc. to provide threat and vulnerability assessment services in the amount of \$352,800, with a 10% contingency of \$35,280, for a total authorized contract amount not to exceed \$388,080.
- B. Motion No. M2017-79: Authorizes the chief executive officer to execute a three-year contract with two one-year options with Parsons Brinckerhoff to provide on-call security certification services for capital projects as part of the Security Certification Program in the amount of \$484,531 with a 10% contingency of \$48,453 for a total authorized contract amount not to exceed \$532,984.
