## **PROPOSED ACTION**

Adopts the permanent station names for the Tacoma Link Expansion and renames the existing Commerce Street Station.

## **KEY FEATURES SUMMARY**

- This action adopts the permanent names for the seven stations included as part of the Tacoma Link Expansion and renames the existing Commerce Street station.
  - o Theater District
  - o Old City Hall
  - o Stadium Way/S 4th
  - Stadium District
  - o Medical Center North
  - o 6th Avenue
  - o Hilltop District
  - Medical Center South
- The proposed permanent station names meet the naming criteria established by the Board in the Facility and Link System Naming Policy. The policy states that station names should:
  - Reflect the nature of the environment: neighborhoods, street names, landmarks, geographical locations.
  - Be brief, easy to read and remember.
  - Comply with federal Americans with Disabilities Act (ADA) guidelines and requirements and be limited to 30 characters.
  - Avoid commercial references because they may change, prove confusing to the public, and be costly to change.
  - o Avoid similar names or words in existing facility names.
- The Facility and Link System Naming Policy calls for the Board to adopt permanent facility
  names when it baselines a project budget and schedule (Gate 5 of the Phase Gate process).

# BACKGROUND

The Tacoma Link Expansion is a 2.4-mile extension of light rail from the Theater District in downtown to the Hilltop neighborhood in Tacoma. The extension will travel at-grade, in-street with traffic along Stadium Way, North 1st Street, Division Avenue, and Martin Luther King Jr. Way. The project includes six new stations, relocates the Theater District Station, expands the existing Tacoma Operations and Maintenance Facility (OMF), and provides for additional light rail vehicles.

The project began final design in 2016 and is scheduled to begin revenue service in May 2022.

The Board adopted the Facility and Link System Naming Policy in February 2012. The policy established a process, timeframe, and criteria for naming facilities. The process includes three phases: internally identify and evaluate potential names based on defined criteria; receive input from the public, local jurisdictions, and the Sound Transit Board; and approval by the Board at Gate 5 of the Phase Gate process.

The policy requires public and stakeholder input be received during the 30 percent facility design review process and regular project communications with the public and stakeholders. To meet this requirement, public meetings and materials included discussion of potential names and collection of public feedback. Based on this feedback along with input from the community and partner jurisdictions, Sound Transit extended the station naming public involvement process to include:

- The pre-60 percent milestone for station design and public meeting.
- An online open house with station naming survey promoted on social media and newsletters.
- A 60 percent public meeting and a second online survey on the top station naming suggestions from the public.

In addition to naming the new stations, the Tacoma community requested the Board consider changing the name of an existing station. The station is located at 11th and Commerce Street and is currently called the Commerce Street Station. With the elimination of the Theater District Station on the current alignment, the public asks to rename Commerce Street Station to Theater District Station. Sound Transit outreach has included this in the aforementioned efforts and recommends the Board consider and approve this name change.

After consultation with the City of Tacoma, the permanent station names are recommended as follows:

There is no financial impact for this action, as signage costs are not determined until the project baseline budget is adopted. This action results in no change to signage production throughout the Link system as these costs are anticipated and fabrication has not yet occurred.

## PUBLIC INVOLVEMENT

Tacoma Link Expansion outreach staff provided stakeholders, jurisdictional partners, and transit partners with information about the naming process and the variety of methods used to obtain feedback. Methods included an active station naming table at two open houses, postings on social media inviting public comment on stations design and names online, and the distribution of electronic newsletters with a survey link to more than 3,600 subscribers on the project email distribution list for each of the two surveys. All project communications about potential permanent station names identified the Board as the final authority in determining permanent station names.

Tacoma Link Outreach staff will coordinate additional public involvement regarding the announcement of station names.

#### TIME CONSTRAINTS

A one- or two-month delay would not create a significant impact to the schedule.

### PRIOR BOARD/COMMITTEE ACTIONS

<u>Resolution No. R2012-02:</u> Established a policy for naming all Sound Transit facilities including stations, maintenance bases, portals and other facilities including the Link system line and extensions.

### MOTION NO. M2017-106

A motion of the Board of the Central Puget Sound Regional Transit Authority adopting the permanent station names for the Tacoma Link Expansion and renaming the existing Commerce Street Station.
