PROPOSED ACTION

Authorizes the chief executive officer to execute a three-year contract with two one-year options to extend with FCV USA, Inc. to provide on-call web developer services for a total authorized contract amount not to exceed \$3,432,000.

KEY FEATURES SUMMARY

- Sound Transit currently maintains and operates two web sites, soundtransit.org for the desktop and m.soundtransit.org for mobile devices, and is currently in the process of redesigning and redeveloping them into a single responsive site that will show the appropriate format for the device on which it is being viewed.
- The web sites provide trip planning and real-time arrival information via an interactive map, Link light rail, Sounder commuter rail and ST Express bus schedules and schedule alerts, Sound Transit news and information including the latest updates on capital projects and plans, and serve as the portal for accessing Sound Transit Board activity and records.
- Under this contract, FCV USA, Inc. will assist agency staff in the development and testing of the web site along with the maintenance and enhancement of the site.

BACKGROUND

Aligned with Sound Transit's objective of increasing ridership, soundtransit.org is the main channel for customer and community information and site traffic. Use of the sites is growing rapidly as ridership grows, especially from mobile devices.

Sound Transit has learned through user research and expert/peer review that the currently deployed web site solution is not adequate to meet customer and community stakeholder needs. In addition, the existing model results in duplicated efforts (with separate web templates for desktop and mobile users) and is difficult for the Information Technology development team and web content providers to maintain. As a result, the agency will completely redesign the web site using modern responsive development tools and technology to offer a single solution that adapts to the device which it is being viewed.

Due to the need to redesign the website, Sound Transit Information Technology requested submittals for a vendor to provide coding development, testing and ongoing maintenance, and website enhancements.

PROCUREMENT INFORMATION

On June 30, 2017, the Agency solicited proposals for On-Call Web Developer Consulting Services. Sound Transit received 14 proposals.

Sound Transit's evaluation team determined that FCV USA, Inc.'s proposal is the response that best meets the evaluation criteria, offered the best value, and is in the best interest of Sound Transit.

FISCAL INFORMATION

The proposed action will be funded from the services category within the Finance and Information Technology department's annual operating budget. The 2017 services category budget is \$17,281,428 of which \$6,522,848 has been spent August year-to-date. Of this contract, a total of \$70,000 is estimated to be spent in 2017 and is within the agency's budget authority. With approval of this action, the remaining annual budget amount is sufficient to fund other department expenditures anticipated in the 2017 annual budget.

Funding for the additional years of the contract will be included in future annual budget requests.
