PROPOSED ACTION

Authorizes the chief executive officer to execute a grant agreement with the Department of Homeland Security for an amount not exceed \$662,138 for a secure radio communication network.

KEY FEATURES SUMMARY

- This action will authorize the chief executive officer (CEO) or his designee to execute a grant agreement with the Department of Homeland Security to reimburse the agency a total amount not to exceed \$662,138 for the procurement and installation of a secure radio network to be completed by the end of August 2020.
- The grant agreement provides 100 percent federal grant funding (no local match is required) to procure and install a redundant secure radio communication network that will be utilized by Sound Transit's Security and Emergency Management personnel, Sound Transit Police, Operations staff, and first responders within Sound Transit's service area.
- This grant will fund a redundant radio system to the King County radio system that Sound Transit will own, operate, and control in the event that King County operating frequencies become unavailable in disaster or emergency events.
- If this action is approved, staff will return to the Board to request approval of a contract to install the secure radio network.

BACKGROUND

In June 2017, Sound Transit applied for and received grant funding from the Department of Homeland Security's Transit Security Grant Program in the amount of \$662,138 to pay for the development and implementation of a secure radio communication network. This network will be utilized by Sound Transit's Security and Emergency Management personnel, Police, Operations staff, as well as local, regional, and federal partners and first responders for the Sound Transit service area. The project will provide a secure and reliable radio system for both intra- and interagency coordination during critical communication situations and events and/or acts of terrorism. This system will enable Sound Transit to have more radio coverage than what it currently has through agreement with King County's radio system. This radio system will be used in conjunction with King County's system. Sound Transit will own and operate this radio system.

This project is 100 percent reimbursable under the grant. The agency will receive the grant funds as eligible costs are incurred and submitted for reimbursement.

Resolution No. R2016-23 authorizes Sound Transit's chief executive officer to sign Federal Transit Administration (FTA) grant agreements but is silent on non-FTA grant agreements; therefore, the agency is seeking Board approval to allow the CEO or a designee to sign this grant agreement.

Sound Transit is in the process of developing a policy for future Board action that will authorize the CEO or designee to sign non-FTA grant agreements.

FISCAL INFORMATION

The proposed action will enable Sound Transit to receive a Department of Homeland Security Grant in the amount of \$662,138. The grant will reimburse 100% of eligible expenditures, up to the maximum grant amount of \$662,138. Any additional costs will be borne by Sound Transit.

The Board will be asked to authorize a budget revision to create a 2018 annual project budget for the work associated with the grant, when they adopt the Proposed 2018 Budget and Proposed 2018 TIP.

SMALL BUSINESS/DBE PARTICIPATION, AND APPRENTICESHIP UTILIZATION

TIME CONSTRAINTS

The Department of Homeland Security requires grant agreements to be executed within 90 days of award. The award was announced on September 12, 2017, and needs to be signed by December 12, 2017. A one-month delay would risk losing the grant funds.
