## PROPOSED ACTION

Authorizes the chief executive officer to increase the contingency for the Northgate Link Extension civil construction management consultant services contract with North STAR, a joint venture of CH2M-Hill, Inc. and Jacobs Project Management Company, in the amount of \$1,800,000, for a new total authorized contract amount not to exceed \$84,830,456.

## **KEY FEATURES SUMMARY**

- North STAR provides construction management services for the civil construction contracts associated with the Northgate Link Extension.
- The contract scope of work includes the following construction management and support functions: program management; resident engineering; office engineering; technical support and inspection; construction cost estimating; contract change management; scheduling; quality assurance oversight; environmental inspection and testing; document control; and tracking of diversity, small business and project labor agreement requirements.
- An increase to the contract contingency is required to fund construction management services for the Northgate Link Extension trackwork construction contract, a construction contract that was not anticipated when the original civil construction management consultant (CMC) services contract was negotiated and awarded in 2012.
- In 2012, trackwork construction was planned to be included within the systems construction contract, similar to the approach used on the University Link Extension. Subsequently, based on experience gained during University Link Extension construction, the decision was made on the Northgate Link Extension to separate trackwork construction from systems construction. Additional CMC resources are now required to manage this separate construction contract.

## BACKGROUND

The Northgate Link Extension extends light rail approximately 4.3 miles from the University of Washington Station to the Northgate Station. The project features approximately 3.4 miles of twinbored tunnels with two underground stations, one at Brooklyn Avenue NE and NE 45th Street in the University District and one at 12th Avenue NE and NE 65th Street in the Roosevelt neighborhood. The alignment includes about 0.9 miles of guideway that transitions from tunnels to an elevated structure and an elevated station that spans NE 103rd Street, near the Northgate Mall.

In September 2010, the Sound Transit Capital Committee authorized a contract with McMillan Jacobs Associates to refine the preliminary engineering work done under the Sound Move program and perform final design. Final design began in October 2010 and advanced into construction in 2012 with the start of early demolition and site preparation at the station sites.

Construction work for the Northgate Link Extension was ultimately divided into 12 separate construction contract packages (11 civil and 1 systems). This construction management consultant, North STAR, provides resident engineering teams to manage and administer the 11 civil contracts.

To date, overall construction for the Northgate Link Extension is approximately 43 percent complete. All tunnel excavation is complete and all three station contracts are well underway. The Northgate Link Extension is scheduled to be complete in September 2021 and will provide an interim terminus for Link at Northgate until the Lynnwood Link Extension is operational.

## **PROCUREMENT INFORMATION**

Sound Transit advertised this work as a Request for Qualifications and notified proposers that construction management of trackwork may be added to the contract at a later date. Sound Transit received four proposals. Two teams were shortlisted and interviewed. North STAR, a joint venture of CH2M-Hill, Inc. and Jacobs Project Management Company, was determined to be the best qualified team for this work.

## **FISCAL INFORMATION**

The baseline budget for the Northgate Link Extension is \$1,899,755,500. Within that amount, \$85,440,106 has been allocated for civil construction management in the construction services phase. The proposed action would increase the commitment for this line item by \$1,800,000 to a revised total commitment of \$84,830,456, leaving a remaining uncommitted budget balance of \$609,650.

This action is within the baseline budget and sufficient monies remain after approval of this action to fund the remaining work in the construction services phase.
