Task Order Agreement with WSDOT for Construction Services of the I-5 Lynnwood-Mountlake Terrace Bus-on-Shoulder improvement project

PROPOSED ACTION

Authorizes the chief executive officer to execute a task order with Washington State Department of Transportation to provide construction services for improvements that will allow authorized transit buses to operate on a segment of the inside southbound shoulder of I-5 for the purpose of bypassing congestion on the adjacent HOV lane and enhancing transit service speed and reliability in the amount of \$265,421, with a 5% contingency of \$14,579, for a total authorized contract amount not to exceed \$280,000, contingent upon Board approval of the 2018 Budget.

KEY FEATURES SUMMARY

- The I-5 Lynnwood-Mountlake Terrace shoulder improvements are undertaken as an element of the "Bus-on-Shoulder" (BOS) ST3 Early Deliverables Program.
- This Task Order will provide construction services including:
 - Improvements to the pavement, drainage, striping, signage and other features as necessary along the southbound inside shoulder of I-5 between 44th Ave West in Lynnwood and 236th St SW that together create a special use shoulder for transit buses; and
 - Construction management services to include inspection, project control, and quality assurance.
- The improvements will be constructed as a Task Order issued under the Umbrella Construction Agreement between the Washington State Department of Transportation (WSDOT) and Sound Transit that was approved by the Board in 2002.

BACKGROUND

The purpose of BOS program is to improve transit speed and reliability by enabling buses to avoid schedule delays through the use of shoulders on freeways and other state route facilities during periods of congestion in general traffic and/or HOV lanes. Projects implemented under this program will require coordination and further study with transit partners, WSDOT, and the Federal Highway Administration (FHWA) in order to determine locations that may be feasible for this program. Funding of the program is provided by Sound Transit, and management of the program will be led by WSDOT with oversight from Sound Transit.

The location and extent of the improvements were determined by WSDOT in consultation with Community Transit and Sound Transit. Both agencies provide fixed-route bus services along I-5 through the project area (with Community Transit operating Sound Transit's ST Express bus routes). These services currently experience chronic delays to their schedule due to traffic congestion on the inside HOV lane and general purpose lanes.

The existing shoulder adjacent to the HOV lane will require relatively minimal modifications or additions to signage, pavement, drainage, striping and other roadway features in order to allow

buses to enter, travel along, and exit the shoulder in order to bypass adjacent traffic. WSDOT has completed design and environmental review of this segment. WSDOT policy will require bus speeds to be limited to 35 mph or 10 mph above the average speed of traffic adjacent to the shoulder, whichever is less.

WSDOT intends to advertise this project as soon as authorized by Sound Transit through the Task Order, which could occur before the end of 2017. Construction is anticipated to begin 3Q 2018, with the project in service by the end of the year.

WSDOT will be responsible for all environmental compliance, construction, operation and maintenance of the project.

PROJECT STATUS



Projected Completion: 4Q 2018

FISCAL INFORMATION

The Bus on Shoulder program is part of the early deliverable projects in the ST3 plan approved by voters in 2016. The Bus on Shoulder program completed Phase Gate – Gate 1 – Establish Project in November. The initial project allocation for this program was included in the 2018 Proposed Transit Improvement Plan.

Contingency on the adoption of the 2018 Proposed Budget and Transit Improvement Plan, this action is within the Authorized Project Allocation to Date and sufficient monies remain after approval of the action to fund the remaining work in the Preliminary Engineering phase as contained in the current cost estimates.

The Authorized Project Allocation to Date for the new Bus on Shoulder Project is \$3,878,000. Within that amount \$280,000 has been allocated to the Construction phase. The proposed action would commit the whole amount of \$280,000 to this line item.
