Weller Street Bridge Structural Repairs Contract Award

Proposed action

Authorizes the chief executive officer to execute a contract with Combined Construction Inc. to provide construction services for the Weller Street Bridge structural repairs in the amount of \$69,000, with a 16 percent contingency of \$11,040, for a total authorized contract amount not to exceed \$80,040.

Key features summary

- The bid price for the work of this contract is 26% higher than the Sound Transit Independent Cost Estimate. Sound Transit committee approval is required when the bid price is 20% or more than the Independent Cost Estimate per Resolution No. R2018-40, the Board's Procurement, Agreements and Delegated Authority Policy.
- The scope consists of repairs to the spalled concrete parapet and the secondary steel pin connection at the northeast section of the bridge. In addition, the existing compression seal at the sidewalk in front of the gate and at west end of the bridge will be removed and replaced with new seals. If repairs are not performed in a timely manner, further damage to the bridge structure may develop.
- As a result of an IFB one bid was received with a price of \$69,000.00 which was 26% higher than the independent cost estimate (ICE) of \$54,660.00. The independent cost estimate was prepared estimating at a lower labor rate and material cost for concrete work and expansion joints.

Background

During the most recent bridge inspection, it was observed that the canopy connection at the northeast corner of the bridge exhibited concrete spalling on the 4th Ave parapet. The concrete surrounding the base plate of the vertical member was also cracked and spalled, possibly as a result of longitudinal bridge expansion and contraction.

The bridge inspector recommended repairs to the spalled area at the 4th Ave parapet at the northeast corner of the bridge to allow for movement. Sound Transit DECM department staff developed a scope of work for the recommended bridge repairs as well as the replacement of a failing compression seal in accordance with the original design documents for the Bridge.

There are no immediate safety risks with the continued use of the pedestrian bridge.

Procurement information

The subject contract award for Weller Street Bridge Structural Repairs is the result of an Invitation for Bid that was sent to specified Small Works Roster firms on the MRSC Roster. One bid was received by Sound Transit. The apparent responsive, responsible low bidder is Combined Construction, Inc. with a price of \$69,000.00 which is 26% higher than the independent cost estimate (ICE) of \$54,660.00. The independent cost estimate was prepared estimating a lower level of effort on the concrete work and expansion joints.

Sound Transit staff determined that the bid amount is fair and reasonable after confirming that the low bidder's interpretation of the scope of work is valid.

Fiscal information

The proposed action with Combined Construction Inc. will be funded from the Services category within the Operations department's annual operating budget. The Services category budget is \$76,846,533, of which a total of \$80,040 is estimated to be spent in 2019 for the Weller Street Structural Repairs, and is currently within the agency's budget authority.

After the approval of this action, the remaining annual budget amount will be used to fund other department expenditures anticipated in the 2019 annual budget.

- The asset based fees for the total assets are currently at .09 percent, and will be reduced to 0.07 percent under the new contract. Sound Transit pays the administrative fees for the retirement program. This amount is included in the total contract amount. The bid price for the work of this contract is 26% higher than the Sound Transit Independent Cost Estimate. Sound Transit committee approval is required when the bid price is 20% or more than the Independent Cost Estimate per Resolution No. R2018-40, the Board's Procurement, Agreements and Delegated Authority Policy.
