## **Contract for Insurance Brokerage and Consulting Services**

## **Proposed action**

Authorizes the chief executive officer to execute a three-year contract with two one-year options to extend with Arthur J. Gallagher Risk Management Services, Inc., to provide insurance brokerage and consulting services for the Agency Operations Insurance Program, Rail Operations Insurance Program, and the administration of the existing Owner Controlled Insurance Program for a total authorized contract amount not to exceed \$2,770,250.

## **Key features summary**

- The contract scope includes insurance brokerage and consulting services for Sound Transit's Agency Operations Insurance Program (AOIP), Rail Operations Insurance Program (ROIP), and the Administration of the existing Owner Controlled Insurance Program (OCIP), which includes:
  - Overall marketing, negotiation, placement of new and renewal insurance coverages, account administration, loss control services, and claims administration support services for the agency, including Sounder Commuter rail, Link light rail, Tacoma Link light rail, Commercial General Liability, Fleet Auto Liability, Pollution Liability, Crime and Fidelity, Professional Liability, Cyber Liability and Property.
  - OCIP administration support services and reporting.
  - Insurance and risk management consulting on the capital development program for the current OCIP and other risk financing program structures.
- The newly selected consultant will be compensated on a fixed fee compensation structure rather than a commission-based compensation structure calculated as a percentage of insurance premiums. The contract scope of work and specific duties and responsibilities to be performed are defined by a brokerage service agreement. The combination of a fixed fee compensation structure with a brokerage service agreement will provide the best value for the insurance brokerage and consulting services for Sound Transit's AOIP, ROIP, and OCIP Administration.
- The amount requested is sufficient to cover the three-year contract and the two one-year options to extend.

# **Background**

Currently, Insurance Brokerage and Consulting Services are provided by Aon Risk Insurance Services West, Inc. (Aon). This current contract expires on December 31, 2020. With Sound Transit's significant asset and exposure growth, combined with a volatile Global Insurance Marketplace, Sound Transit determined it was in its best interest to advertise a Request for Proposals for Insurance Brokerage and

Consulting Services prior to expiration of the current contract. The goal is to ensure the highest quality representation while marketing Sound Transit's current and future insurance programs.

## **Procurement information**

Prior to issuing the solicitation for the Insurance Brokerage and Consulting Services, Sound Transit considered the project scope, the determining factors for contract award, and the need for proposal discussions and revisions, determining that a Request for Proposals procurement method was the most advantageous.

On March 25, 2020, Sound Transit advertised a Request for Proposals No. RTA/RP 0038-20 for Insurance Brokerage and Consulting Services. Aon and Gallagher were the only two firms that submitted proposals, and Arthur J. Gallagher Risk Management Services, Inc. (GALLAGHER) was selected as the most qualified firm to provide the AOIP, ROIP and OCIP Administration brokerage and consulting services.

## **Fiscal information**

The proposed action will be funded from the services category within the Finance Department's annual operating budget. Spending for this contract will begin in 2020 and is included in the 2020 budget. The services category budget is \$5,373,866 of which a total of \$250,000 is estimated to be spent in the first year of the contract and is within the agency's budget authority. After approval of this action, the remaining annual budget amount will be used to fund other department expenditures anticipated in the 2020 annual budget.

Funding for the additional years of the contract will be included in future annual budget requests.
