# Increase Contract Contingency for the Operations & Maintenance Facility Tenant Improvement project

## **Proposed action**

Authorizes the chief executive officer to increase the contract contingency for the Operations Maintenance Facility Renovation project construction services contract with Western Ventures Construction Inc. adding contingency in the amount of \$100,000, for a new authorized contact amount not to exceed \$5,160,000 plus applicable taxes.

# **Key features summary**

- This action would increase the contract contingency for the contract with Western Ventures which may be needed for additional expenses which were not anticipated in the original contract.
  - The current project forecast suggests the project may exceed the approved contract value.
    - Authorized 97% of the contract value.
  - Changes to date are related to project schedule impacts due to COVID-19 restrictions and unforeseen hidden site conditions.
  - COVID-19 protocols and the effect thereof are reflected in the February 2020 project completion date.
  - The estimated sales tax for this request is \$10,100.
- The project scope of work remains unchanged.


# **Background**

In 2009 the Link Operations and Maintenance Facility (OMF) was opened for use with mostly King County staff and minimal Sound Transit oversight staff. Throughout the years, the King County staff has increased causing the Sound Transit oversight staff to increase. With the passage of ST3 the Link OMF will need to support the Central Link (West Seattle to Ballard) and the South Link (Angle Lake to Tacoma) until the South OMF opens in 2028.

In 2018, the Board established the Operations and Maintenance Facility (OMF) Renovations project to address this increase which intended to regroup departments and divisions, gain efficiencies for staff, provide security for the Link Control Center per Homeland Security requirements, and reduce long term operational costs. At this time, the project is 80% complete.

Western Ventures was brought on to complete the interior renovations of the OMF and approved by the Board through Motion No. M2019-83. The contract includes the remodel of the interior of the Central Operations and Maintenance Facility to increase space utilization. Existing oversized offices will be reconfigured into the agency standard sizes to create additional spaces and increase efficiency. Operators and dispatch will be relocated to the second floor to provide security for the Link Control Center per Homeland Security requirements, and increase efficiency by eliminating daily trips by the Operators to the fourth floor. LRV Fleet expansion increases the number of operators. Due to extremely high occupancy in the building, the project needs to be completed in four separate and distinct phases to free up space for the contractor to perform work.

# **Project status**



Projected completion date for Operations and Maintenance Facility Project is February 2020.

## Fiscal information

This action is within the authorized project allocation and sufficient monies remain after approval of this action to fund the remaining work in the construction phase.

The authorized project allocation for the OMF Renovations project is \$11,104,957. Within that amount \$8,083,841 has been allocated to the construction phase. The action would commit an additional \$110,100 and leave a budget balance of \$2,059,817 in the construction phase.
