



Motion No. M2021-77

A motion of the System Expansion Committee of the Central Puget Sound Regional Transit Authority recommending that the Finance and Audit Committee forward the System Expansion portions of the Proposed 2022 Budget and Transit Improvement Plan to the Board with a do-pass recommendation, including the revision to the Proposed 2022 Budget and Transit Improvement Plan in Attachment A.

Background

Sound Transit is developing and operating regional transit infrastructure through three major voter-approved programs: Sound Move approved in 1996, Sound Transit 2 (ST2) approved in 2008, and Sound Transit 3 (ST3) approved in 2016. Transit infrastructure planning, design, and construction account for the majority of the agency's annual budget.

Section 1.

System Expansion annual project budgets in the Proposed 2022 Budget, excluding System Expansion – Other, total \$2,088.2 million, plus revisions of \$6.8 million for a revised budget total of \$2,095.0 million:
