To the Expansion Committee:

Thank you for the opportunity to comment on Sound Transit's expansion plans. My name is Ed Miller and I'm the President of the GarageTown Federal Way Condominium Association.

The families and businesses that make up the community of owners of GarageTown Federal Way were relieved at the end of 2021 when the Sound Transit Board selected the S. 336^aSt. as the preferred alternative for the OMF-South Facility. This was an important event for us as it gave some hope that our community would be preserved during Sound Transit's southward expansion. Today, now that the Final EIS has been complete, the choice is even clearer. We hope you will affirm the staff recommendation of the S. 336^asite as the project to be built.

As a reminder, during the DEIS process, 93% of respondents opposed the selection of the site that includes our property, S. 344th. Even the Christian Faith Center in their letter to Sound Transit, and their public testimony in December of 2021, stated that the S. 344thSt. site is actually more impactful to them than selection of the S. 336thSt. site, which was chosen at that time as Sound Transit's preferred alternative.

Lastly, I wanted to thank the work of Sound Transit staff during this long process. Curvie Hawkins, Andrew Austin, Sagar Ramachandra, Chelsea Levy, and many, many more. Over the years, we have had the opportunity to work with many on your staff and they were always responsive to our concerns and transparent about the process. Even though the discussions were at times stressful for us as we considered potential impacts to our property, we sincerely appreciated Sound Transit staff's approach to working with us on this very consequential decision for our neighborhood community.

Thank you again for listening to the community. I urge to you select the S. 336^wsite as the project to be built for the OMF-South facility.
