Dear Sound Transit Board Members,

I am writing to express my support for the originally planned 4th Ave (CID) & Midtown stations as part of Sound Transit 3. I believe the decisions Sound Transit and the City of Seattle make today will have a significant impact on Seattleites for generations to come. More specifically, I believe the alternative being considered, of stations north and south of the CID, would be a grave misstep in designing an effective regional transit network.

Sound Transit and the City of Seattle have the opportunity to create the largest transit hub in the Pacific Northwest. Currently, the CID is not only home to the 1 Line station, but it also is walking distance from Amtrak's King Street Station, the Sounder train, the First Hill streetcar, and countless bus lines connecting the region. Having the future light rail lines connect to this same area just makes logical sense for all transit riders.

The alternative route, on the other hand, would create out-of-the-way transfers. This would require commuters either having to transfer at a later stop only to head back in the opposite direction on another line, or having a significant walk to another station to transfer lines. All of this wasted time for commuters adds up to wasted revenue for both those individuals and for the region. Additionally, these hardships on commuters will further incentivize driving over public transit, as public transit is only a viable option for the average commuter if it is competitive with driving. With all this in mind, any immediate cost savings from the proposed alternative plan would be negligent in the long term.

As a CID resident, the prospect of the CID becoming a regional transit hub excites me. The Chinatown-International District is a historically overlooked and neglected neighborhood in desperate need of revitalization. Countless small, minority owned businesses are in danger of

disappearing, and long time residents are on the verge of being displaced. I believe a light rail hub along with more transit-oriented development would be a boon to the neighborhood's economy and general accessibility. Avoiding the CID entirely would just continue the city's trend of neglecting a neighborhood that has so much to offer.
