To the Office of the Washington State Auditor:

We are providing this letter in connection with your audit of the Central Puget Sound Regional Transit Authority (Sound Transit) for the period from January 1, 2022, through December 31, 2022. Representations are in relation to matters existing during or subsequent to the audit period up to the date of this letter.

Certain representations in this letter are described as being limited to matters that are significant or material. Information is considered significant or material if it is probable that it would change or influence the judgment of a reasonable person.

If we subsequently discover information that would change our representations related to this period, we will notify you in a timely manner.

 - d. Communications from regulatory agencies, government representatives or others concerning possible noncompliance, deficiencies in internal control or other matters that might concern the objectives of the audit.
