Proposed action

Authorizes the chief executive officer to execute a contract with Stacy & Witbeck, Inc. to provide construction services for the Federal Way Link Extension project for traffic mitigation in the amount of \$11,648,140, with a 20 percent contingency of \$2,329,628, for a total authorized contract amount not to exceed \$13,977,768.

Key features summary

- The project will consist of intersection improvements at six different locations in the Federal Way
 Link Extension (FWLE) project vicinity as required by the Record of Decision for the project.
 Improvements include the addition of turn lanes, signal modifications to better enable the public to
 access the stations by reducing traffic congestion.
- Following extensive collaboration with local jurisdictions and WSDOT, these improvements were
 finalized then packaged into a single procurement to more efficiently deliver the work. The contract
 scope of work includes improvements of multiple intersections in the Cities of Kent and Federal
 Way, and on Washington State Department of Transportation (WSDOT) right of way.
- These improvements consist of signal improvements, grading, drainage, paving and channelization, cast-in-place and soldier pile retention walls along public right-of-way, and wetland mitigation.
 Pedestrian upgrades are included at project sites, including widened sidewalks, upgraded ADA ramps, tree wells and planter strips.
- Three bids were received for this procurement. The apparent low bidder voluntarily withdrew its bid based on entering an incorrect sales tax amount. The second low bid was determined to be responsive and responsible, and the price was determined to be fair and reasonable.
- Applicable taxes are estimated at \$1,078,140 and are included in the total bid price.

Background


The Record of Decision for FWLE initially included 10 locations for traffic mitigation improvements. This was reduced to six locations by:

• Updated analysis of two intersections resulting in a change to no mitigation required for those intersections; and

Prior installation of required improvements at two intersections by the City of Kent.

In consultation with Sound Transit, FTA confirmed the refinements to the project traffic mitigation requirements in March 2023. The FWLE Traffic Mitigation project is a set of six intersection improvements located in the Cities of Kent, Des Moines and Federal Way, including on WSDOT Right-of-Way. The improvements include right turn pockets, left turn lanes, signal modifications and associated improvements. These improvements are required per the FWLE Record of Decision and Final Environmental Impact Statement and are scheduled to be completed by the start of Revenue Service for the Federal Way Link extension. This project is led by Sound Transit and designed in coordination with the Cities of Kent, Des Moines and Federal Way, and WSDOT.

Procurement information

The Invitation for Bid (IFB) solicitation was advertised on March 11, 2024. This project is federally funded and, in accordance with FTA rules, this IFB was advertised for at least 30 days. An addendum extended the due date for the submission of the bids from April 4, 2024, to April 19, 2024. Sound Transit received a total of three bids.

The apparent low bidder, in accordance with the IFB solicitation's Instructions to Bidders, withdrew their bid due to claim of error for erroneous sales tax calculations. The claim of the error and subsequent withdrawal of the bid was accepted by Sound Transit. Due to the withdrawal of the apparent lowest bidder, a responsiveness and responsibility reviews were conducted for the two remaining bids. The apparent second lowest bidder, Stacy-Witbeck, Inc., was deemed responsive and responsible and is therefore eligible for the award.

The independent cost estimate was developed by a consultant and reviewed by Sound Transit's Cost Engineering Group. The lowest bid amount from the bidder deemed responsive and responsible is lower than the final independent cost estimate.

A price analysis was conducted by the Contract Specialist. The price analysis deemed the responsive low bid to be fair and reasonable based on review of independent cost estimate and competitive bids.

Fiscal information

This action is funded by the project's baseline budget and there are projected sufficient amounts in the budget remaining to fund the remaining work. The current project budget is included in the existing Long Range Financial Plan forecast.

The baseline budget for the Federal Way Link Extension project is \$2,451,535,000. Within the \$1,768,749,595 construction phase, \$20,000,000 has been allocated to the F210 Traffic Mitigation

Improvements Contract. The proposed action would commit \$13,977,768 to this line item and leave an uncommitted line-item balance of \$6,022,232.
