#### 2024 Service Context

## **Spring**

- Implemented reduced service levels on South Corridor regional bus service
- Initial 2 Line segment opened from South Bellevue to Redmond Technology on April 27, 2024

#### Fall

- Lynnwood Link Extension opening August 30<sup>th</sup>
- I-5 North bus restructure to be implemented Sep 14<sup>th</sup>



## 2025 Service Plan

Downtown Redmond Link Extension
ST Express service levels in South Corridor

#### Downtown Redmond Link Extension Service Plan

#### 3.4-mile extension will serve two new stations on the 2 Line

#### **Anticipated to open in Spring 2025**

Continue existing 2 Line service levels

- All-day and all-week at 10min headways
- 5:30am 9:30pm
- 2 car trains

We project ridership between 6,900 and 8,200 average weekday boardings by Q4 2025

 Average weekday ridership on the initial 2 Line segment is just under 4,000





#### Recent South Corridor ST Express service reductions

In Spring 2024, we implemented a 10% reduction on Pierce Transit operated service due to ongoing staffing challenges.

Riders have reported crowding on routes serving Downtown Seattle and Tacoma

590* (Tacoma - Seattle)	Downtown Tacoma stops and ~1/2 weekday trips suspended
580* (South Hill - Puyallup)	Route Suspended
<b>577</b> (Federal Way - Seattle)	All midday trips and most Sunday trips suspended
578 (Puyallup - Seattle)	Some evening trips suspended
594 (Lakewood 0 Seattle)	Some low ridership weekday and Sunday trips suspended

<sup>\*</sup>Major service change; requires Board action if projected to remain for more than 1 year



#### Responding to reduced ST Express service levels

- Higher capacity buses are now allocated in early morning when there is the most demand
- We have adjusted the schedule for the Fall 2024 service change to better match trip-times with high ridership demand
- We are working with our operating partners to determine if there is a possibility of restoring recent reductions

This summer we are seeking public input about service restoration priorities, if feasible.

Additional Board action formalizing the spring service reductions will be required in October if we are unable to restore these reductions.

# Light rail extensions complete the ST2 buildout

After DRLE opens, two more openings will complete the ST2 Link system:

- The 2 Line connects to the 1 Line
- The 1 Line extends to Federal Way

As we learn more about project completion timelines, we will seek Board approval for Link service plans.

 We will include information about frequency, hours of service, travel times, projected ridership and capacity on our light rail vehicles



# The ST2 build-out delivers a connected transit system

Riders will experience significant benefits in mobility and access across the region:

- Improved frequency between downtown Seattle and Lynnwood, where Link is busiest
- New Link service will allow riders to more reliably complete trips
- Connections between Link and bus service will provide access to new destinations across the region, directly or with one transfer

#### How ST Express will serve the new ST2 transit system

We recommend no bus restructures until after the 2 Line connects to the 1 Line

After we have determined Link service levels, we will request Board approval for how regional bus service can be restructured to serve the new light rail system.

- We anticipate implementing the restructures in 2026
- We will factor in major regional events such as the World Cup and significant construction impacts on I-5

- Develop service plans for the new Link extensions, completed ST2 system
- In coordination with transit partners, analyze opportunities for ST Express to connect to the new transit system
- Update Board as information about service becomes available, propose 2026
   Service Plan in October 2025.
