- On track for Q4 2025 Revenue Service.



Known Risks & Mitigations

- Critical or Near-Critical Path work ahead:
 - Final polyurea coating repairs on the floating bridge
 - Power and systems tie-in work at International District / Chinatown Station to connect 1 Line
 - System Integration Testing
- Ongoing discussions with contractor and staff to manage work to meet or improve current schedule.


Today's actions

- Resolution No. R2024-23: Amends the East Link Extension project baseline budget to settle delay claims and provide funding to complete the extension by the forecast revenue service date.
- Motion No. M2024-63: Increases the contract contingency with Mass Electric Construction Company for the East Link Systems Construction contract in the amount of \$30,000,000 contingent upon approval of Resolution No. R2024-23.
- Motion No. M2024-64: Authorizes the chief executive officer to increase certain East Link Extension contract and/or agreement amounts as necessary, for a total authorized cumulative increase not to exceed \$50,000,000, contingent upon approval of Resolution R2024-23.
- Motion No. M2024-65: Authorizes an amendment to Task Order B-12 under the Umbrella Agreement GCA 3361 with WSDOT for continued construction administration and construction services.


