Board Resolution No. R2023-30 requires the CEO to provide an annual report to the Board summarizing the performance of the agency's procurement, contracts, and agreements program, including accomplishments, challenges, and opportunities. The Procurement, Contracts and Agreements division (PCA) prepared this report.

ACCOMPLISHMENTS & HIGHLIGHTS

New Contracts, Active Contracts, and Agency Agreements

In 2024, PCA managed the agency's procurement and execution of 402 contracts, with a total value of \$394.9M at the time of execution. These contracts include:

- 7 contracts executed greater than \$10M each, with a total value at the time of execution of \$243M, listed in the table below.
- 21 contracts executed between \$2M and \$10M each, with a total value at the time of execution of \$86.7M.
- 374 contracts executed less than \$2M each, with a total value at the time of execution of \$65.2M.

As well, this division played a crucial role in managing procurement and contract activities, overseeing significant transactions and agreements across the agency. These efforts accounted for:

- 1,038 Division Purchase Orders, up to \$10K each, with a total value of \$2.6M.
- 9,402 P-Card transactions, up to \$10K for each purchase, with a total value of \$5.7M.
- By Dec. 31, 2024, PCA administered 1216 open and active contracts during 2024, with a total value of \$13.3B.
- As well, PCA guided the agency's formation and execution of 113 agency agreements during 2024.

Strategic Partner

Over the past year, PCA continuously engaged departments in strategic consultations for timely, effective procurements and agreements to support the agency's business needs. For example, PCA sought early design concepts for the Light Rail Vehicle 3 procurement and released a draft RFP promoting competition, innovation, and efficiency.

Capital Delivery Department Support

PCA actively supported the Capital Delivery Department's development of Multiple Award Task Order Contract (MATOC) and Progressive Design-Build (PDB) solicitation, contract, and procurement processes for 2025 implementation and partnered in delivering multiple industry outreach events.

Project Review Committee (PRC) Recertification

PCA successfully led the agency team that obtained public body recertification to use Design-Build (DB) and GC/CM alternative public works procurement/project delivery methods. We advanced a concurrent renewal process for the two certifications for the first time instead of two separate renewal cycles. Sound Transit's recertification for both DB and GC/CM now extends through May 28, 2027.

Equity in Contracting

PCA worked alongside other agency departments to advance its Equity in Contracting program, representing Sound Transit at the following organizations and events throughout the year like:

2024 Contracting Expo – Partnering for Progress

With the participation of many agency departments, PCA organized, prepared, and hosted the 2024 Contracting Expo virtually to increase visibility and competition for Sound Transit contracts. Presentation topics included Capital Delivery, Service Delivery, and Small Business Participation. Overall participation for the Expo included:

- 779 registrants in 14 countries had full access during and after the Expo.
 - 525 registrants attended the sessions, workshops, and virtual booths.
 - 278 attended the Speed Networking event pairing prime and subcontractors.

Procurement Integrity

Sound Transit staff received Comprehensive Procurement Integrity training workshops twice annually. These trainings included an in-person training in November and on-demand presentations throughout the year both in-person and through Sound Transit University.

Agency Training

Procurement training highlights presented by PCA in 2024 included:

- Contracted Workforce
- Negotiations: PCA hosted two in-person Introduction to Negotiations led by Seattle University law professors.
- Hosted National Training Institute (NTI) Orientation to Transit Procurement

Procurement, Contracts and Agreements Automation Tool (PCAAT)

To simplify the end-to-end procurement and contracting process, PCA worked with Information Technology to obtain an integrated PCAAT system solution. Implementation is underway in phases, gradually replacing the existing disparate tools.

- Agency participation in memberships and sponsorships.
- Allowable incidental purchases.

PCA actively represented the agency on APTA national committees, training programs, and panels. Sound Transit's Chief Procurement Officer (CPO) serves as Chair of APTA's Procurement Standards Policy and Planning Committee.
